Nowlin's professional journey is marked by her commitment to alleviating human suffering. She holds a bachelor's degree in finance from Florida State University, which has provided a strong foundation for her impactful work.

VERONICA ARTEAGA FINALIST (NONPROFIT) President; CEO Exceptional Children's Foundation (ECF)

V eronica Arteaga is the president & CEO of Exceptional Children's Foundation (ECF), and the first woman to hold this leadership position in the organization's history. She is responsible for leading ECF's lifespan continuum of programs and services for children and adults challenged with special needs. This includes a \$28 million operating budget, 375 employees, a 21-member board of directors, and the provision of services to nearly 4,000 children and adults with special needs and their families annually.

A licensed clinical social worker, Arteaga is credentialed in Pupil Personnel Services. She holds a Master of Social Work from USC and a Bachelor of Arts in Psychology from USCS. She is currently developing the ECF's long-term strategic plan to increase public and private funding, ensure fiscal stewardship and sustainability, build business and community partnerships, and increase agency enrollment, advancing the organization's impact in the community.



VERA QUINN FINALIST (FOR-PROFIT) President; CEO Cydcor

Wera Quinn is a transformational leader whose strategic vision and people-first leadership has positioned Cydcor as the industry leader in outsourced sales and customer acquisition. As CEO and president of Cydcor, she has spent over 25 years shaping the company's growth, cultivating top talent and driving exceptional results for the company's Fortune 500 and emerging brand clients.

Quinn began her journey as a recruiter at an independently owned sales company before launching her own business as a bookkeeper. She later joined Cydcor, where her deep understanding of sales and business operations shaped her leadership approach. In 2024, Cydcor achieved double-digit revenue growth for the second consecutive year, setting a company record. Under Quinn's leadership, the company has expanded its network and successfully entered new industries including home security, consumer packaged goods, and experiential marketing, broadening its service offerings and strengthening its market position.



JUDY ZHU FINALIST (FOR-PROFIT) CEO Synear Foods USA

Judy Zhu has been a fierce leader for Synear Foods USA, overseeing all facets of the company's marketing and brand strategy while also guiding a strong team that champions innovation.

Zhu's leadership has influenced Synear's success in a variety of ways, including securing national Costco distribution of its Pork Soup Dumplings across the United States, while overcoming regulatory and supply chain hurdles. The dumplings quickly became one of Synear's best-selling products. Additionally, she spearheaded the launch of more than five new items with Costco. including Wagyu Beef Soup Dumplings, Panda Buns and Ube Dessert dumplings, leveraging cutting-edge product design and R&D advancements to meet evolving consumer demands. Zhu is devoted to staying on top of consumer trends and keeping in close touch with the company's audience. Her expert negotiation also earned Synear a coveted Golden Ticket from Walmart Open Call in 2024.

EXECUTIVE OF THE YEAR HONOREE

KARLA SALAZAR

Executive Director ScholarMatch

arla Salazar is the executive director of ScholarMatch, an organization with the mission of supporting underserved, first-generation college students from low-income backgrounds to earn a bachelor's degree within five years. ScholarMatch serves 1,300 students annually, with an emphasis on students in Los Angeles and the San Francisco Bay Area.

When Salazar joined ScholarMatch in June 2021, the organization and the students it serves had been through some deeply challenging circumstances caused by the pandemic. Even as its students struggled with their virtual classes, funders decreased their support due to fears of a recession while an increasing number of first-generation students nationwide paused or set aside their dreams of college.

Despite these challenges, Salazar's leadership has brought ScholarMatch to new levels. She ideated a vision to expand the organization's programming to community college transfer students and secured funding from Genentech to support this dream. She also developed a partnership with UC Scout to offer free A-G classes – required courses in high school for a student to be eligible to apply to schools in the University of California system.

In 2024, Salazar launched a new initiative to provide 1:1 college coaching to firstgeneration students in Southeast LA. This year, the organization plans to serve up to 200 students and reach 600 students annually in Southeast LA by 2027. She spearheaded partnerships with funders, school districts and school officials to bring this launch to fruition, including a \$1.2 million grant from the Ballmer Group that provided seed funding for college persistence services for Southeast LA students.



MEGAN CREECY-HERMAN FINALIST

President - West Region Prologis

Megan Creecy-Herman is known for being a disciplined and forward-thinking leader in the dynamic supply chain and logistics industry – one of Southern California's most vital economic sectors. As West Region president for Prologis, the world's leading logistics real estate company, Creecy-Herman oversees a 260 million square foot portfolio across 12 major markets, generating more than \$2.5 billion in annual net operating income.

Prologis develops and operates modern, sustainable logistics facilities such as warehouses and distribution centers, leasing them to a wide range of entities, from small and medium-sized businesses to some of the world's most recognized brands. Creecy-Herman has led the digital transformation of the company's property search experience, reimagining how customers discover and lease logistics space. Under her leadership, the team streamlined and digitized the process, eliminating 19 manual steps, five administrative queues and three approval layers.



SHERRI FRANCOIS FINALIST Chief Impact Officer, SoLa Impact;

Executive Director, **The SoLa Foundation**

S herri Francois began her career in journalism, TV news, and documentary film making, producing pieces with Channel One, CBS, CNN, NBC, MTV and HGTV. After 15 years in NYC, where she started a family and earned an Emmy nomination, she returned to LA to become an entrepreneur, founding South Bay Multimedia, a television and video production company.

In 2017, Francois joined SoLa Impact as chief impact officer, where she drives all social impact and community development to ensure SoLa uplifts the communities in which it invests. Her double bottom line strategy focuses on accessibility to high quality affordable housing, jobs, capital and education. Francois established the SoLa Foundation (SoLa Impact's 501c3 affiliate) in 2018 to help end intergenerational poverty in Los Angeles through creating access to STEM career training, higher education, and home ownership in underinvested and under-resourced communities.



EVE GLAZIER, MD FINALIST President, Faculty Practice Group, UCLA Health, Health Sciences Professor of Medicine David Geffen School of Medicine at UCLA UCLA Health

D r. Eve Glazier has served as president of the UCLA Health Faculty Practice Group (FPG) since 2017. As the top executive leader of the FPG, she oversees all aspects of business solutions and administrative functions for Physician Support Services, Managed Care Contracting and the Office of Population Health and Accountable Care at one of the largest academic health systems in the world.

In the fall of 2024, Dr. Glazier helped to launch UCLA Health's first-ever Medicare Advantage Plan, which provides eligible individuals comprehensive health care coverage and convenient access to care. The plan includes 7,000 in-network physicians, specialists, hospitals and clinics comprising UCLA Health, as well as select independent physician associations and medical groups that provide patient-centered care. A trained internal medicine specialist, Dr. Glazier provides expert advice in the weekly syndicated Ask the Doctors column that is popular in news outlets around the country.



SHAWN SHEFFIELD FINALIST Chief Strategy Officer Keck Medicine of USC

S hawn Sheffield, MBA, MHSA, is a highly regarded and energetic health care executive with deep experience in academic medicine. She has led Keck Medicine of USC's clinical growth and expansion efforts for over a decade. Sheffield oversees network development, including mergers and acquisitions, strategic partnerships, capital and venture planning and physician alignment strategies. Under her leadership, the health system's annual revenue has more than tripled, reaching \$3.4 billion. During her tenure, she developed a regional network that spans from Bakersfield to Irvine.

In 2022, Sheffield played a key role, in Keck Medicine acquiring USC Arcadia Hospital, formerly Methodist Hospital of Southern California, bringing residents of the San Gabriel Valley greater access to specialized care and breakthrough technology. She also led the development of the new 100,000 square-foot medical office complex in Pasadena, which will serve the city and surrounding areas beginning in the fall of 2025.

INNOVATOR OF THE YEAR HONOREE

JULIE UHRMAN

CEO; Co-Founder Angel City Football Club

B usiness innovator Julie Uhrman, CEO and co-founder of Angel City Football Club (ACFC), has led the club in becoming the most valuable women's sports team globally, with a \$250 million USD valuation following its sale to Disney CEO Bob Iger and Willow Bay in 2024. Uhrman personally managed the entire sale process, carefully selecting Iger and Bay from multiple bids due to their shared values and strong commitment to developing the soccer program and ensuring players and coaches receive the facilities, resources and funding they deserve.

Uhrman's ability to transform ACFC into a cultural and financial powerhouse is reflected through its record ticket sales, league-leading \$35.4 million revenue in 2024, and unmatched merchandise sales. She leads by fostering a community-first ethos that inspires fans and players alike, building a fan base that averages 19,500 attendees per game – setting a world record for women's football attendance.

Through ACFC's innovative 10% sponsorship model, Uhrman has ensured that \$7.5 million of the club's sponsorship revenue is reinvested into Los Angeles communities, supporting programs focused on equity, essentials and education. She has personally attended over 100 Angel City community events, including partnering with Sprouts Farmers Market to replant LAUSD school gardens where children learn to grow food and prepare meals with fresh fruits and vegetables. Additionally, Uhrman facilitated ACFC's partnership with DoorDash, which has delivered over 2,000,000 meals to shelters, LGBTQ centers, homeless communities and other underserved groups across Los Angeles. Her leadership extends globally through initiatives like iACT, which empowers refugee communities through sports.



JENNIFER ACREE FINALIST Founder; CEO JSA+Partners

ennifer Acree is the founder and CEO of JSA+Partners, a Los Angeles-based communications agency specializing in digital media, consumer technology, and esports & gaming. As the firm's strategic lead, Acree ensures its roster of clients is supported day in and day out, spearheading tailored communications programs that garner tangible results and tie back to business objectives.

Acree launched JSA+Partners with a mission to disrupt a flawed traditional public relations agency model. As new business requests quickly flooded in, she expanded the firm from an individual consulting practice to a boutique agency powerhouse, offering strategic counsel, media relations, thought leadership messaging, and crisis communications. Acree is responsible for launching the firm's innovative Coverage Analysis and Tracking Solution, which enables painless coverage tracking, easy integration with existing PR trackers, quick visualization and analysis through a proprietary, multi-layered filtering system.



JERI HARMAN FINALIST Founder; Chairman Avante Capital Partners

ounder and chairman of Avante Capital Partners, Jeri Harman has more than 30 years of experience in finance and M&A, involving more than \$1 billion in aggregate investments, and has held numerous board roles across more than 20 private middle market companies.

In 2024, under Harman's leadership, Avante Capital Partners invested and committed nearly \$180mm and was named the #3 best performing private credit family of funds, globally, by Pitchbook. That year, the firm launched an innovative employee ownership program not otherwise seen in the finance industry, through which eligible employees gain the opportunity to acquire ownership stakes in the company. Harman also facilitated the firm's Small Business Investing Scholars Internship Program, creating inclusive enterprises by promoting gender, racial and ethnic diversity in the private equity and direct lending industries. The 2024 internship program received more than 1,300 students applying to participate in the opportunity.



PILAR ORTEGA FINALIST Founder; CEO International Technologies and Services, Inc.

W ith over 30 years of experience in the chemical and environmental technology sectors, Pilar Ortega has dedicated her career to creating practical, science-driven solutions to some of the industry's most pressing challenges. As the founder of International Technologies and Services Environmental, she has developed and patented a line of eco-friendly products that reduce hazardous waste, improve worker safety, and lower the environmental impact of hydrocarbon use across multiple industries.

Ortega has overcome significant challenges as a Latina woman in a male-dominated field, remaining focused, purpose-driven, and resilient, while growing her company into a trusted name among major refineries and environmental agencies. Having worked hands-on in industrial settings, Ortega witnessed firsthand the toll traditional chemicals and processes take on workers' health. This fueled her passion to create safer, plant-based alternatives – products that not only perform better but also align with modern environmental standards.



MERCY TOLENTINO STEENWYK FINALIST

CEO; President ForensisGroup

A ercy Tolentino Steenwyk is the founder and CEO of ForensisGroup, a nationally recognized expert consulting firm she launched in 1991 with a vision of bringing clarity to complex cases and justice in the legal system. She founded the firm as a mother navigating a male-dominated industry and built it into a pioneering enterprise that has supported over 30,000 legal matters.

Over the last three decades, Steenwyk has transformed the expert consulting industry by building a rigorous vetting model that connects attorneys, insurers and government agencies with top-tier experts in over 8,000 specialties. Her commitment to integrity and innovation has led ForensisGroup to develop proprietary technology that streamlines expert matching, reducing case delays and elevating outcomes. Her leadership has earned the company repeated recognition in the legal industry, including awards from the National Law Journal and AM Best.

EMERGING WOMAN-OWNED BUSINESS LEADER HONOREE

ANNE-MARGOT RODDE

Founder; CEO **Creators Corp.**

A nne-Margot Rodde has established herself as an influential leader in the traditionally male-dominated gaming industry. As founder and CEO of Creators Corp., a leading Fortnite game studio, she has led collaborations that bridged the gap between traditional sports and gaming, including creating games with the US Open and top professional athletes. These initiatives have addressed the ongoing challenge of integrating real-world sports with the virtual realm, and under Rodde's creative leadership, Creators Corp. won a Webby Award for its highly successful collaboration with basketball star Stephen Curry.

One of Rodde's biggest achievements lies in how Creators Corp. has cracked the code for engaging Gen Z, a demographic many brands and publishers have struggled to reach. By focusing on driving gameplay and player engagement, she unlocked the full potential of Fortnite Creative, transforming it into a dynamic platform for innovative brand experiences. In 2024, Creators Corp. partnered with influential internet personalities such as Dude Perfect creator group, Fortnite star Clix, and more to amass 500 million minutes of play across their games The company doesn't just build games; it creates cultural moments that resonate with millions of players.

As a visionary founder, Rodde has been featured in major outlets like Fast Company, Forbes, Digiday, VentureBeat and Variety. This year, Rodde has spoken at both SXSW and CES, and is gearing up to speak at the Cannes Festival in June. Her drive continues to reshape the future of gaming, not just through her business acumen, but by inspiring the next generation of female creators and leaders.



ASIA YUYU QUIROZ FINALIST Founder BESUKOH

A sia Yuyu Quiroz is the founder and designer behind BESUKOH, a brand she created to express intentional design and honor the strength, complexity and elegance of women. Quiroz was born in Los Angeles to Mexican immigrant parents. During her years at Cal State LA, she interned at Rocnation, where she developed a love for discovering new artists. Her background in communications and years in the music industry contributed to her deep understanding of the cultural impact of creative expression. She began by designing handbags as her first canvas to explore form, function and emotional connection.

BESUKOH is a small ethical brand taking pride in craftsmanship and originality. The company makes unique bags that are ethically and meticulously crafted in one of the meccas of leather goods, Spain. Quiroz's designs are an ode to femininity, celebrating the interplay that between grace and strength.



AMY ROSSETTI FINALIST Founder R[AR]E Public Relations

A my Rossetti is an emerging force in the Los Angeles business landscape, redefining real estate public relations through her boutique firm, R[AR]E Public Relations. With a decade of experience and a track record working with high-profile real estate clients, Rossetti launched R[AR]E at age 27 during the height of the pandemic, building it from the ground up into a national agency headquartered in Beverly Hills.

Rossetti's work elevates narratives around some of LA's most transformative residential and commercial developments, and the visionaries behind them. From revitalization efforts of historic projects to high-end residential spec homes, R[AR]E PR helps attract investment, attention and opportunity for the region and beyond. Rossetti has played a pivotal role in hiring talent locally, including professionals from top institutions like Douglas Elliman and the American Institute of Architects, ensuring LA remains a hub for creative and strategic communications professionals in the real estate space.



KAREN TATMAN FINALIST Founder; CEO KMT Wealth Management

One of the brand's key innovations is its commitment to reusing excess leathers left behind by larger brands at factories — an initiative that within five years has repurposed nearly three tons of leather that would have otherwise gone to waste.

Zambrano later transitioned from brand ownership to building Casupo Manufacturing, a full-service studio that helps emerging designers and established brands produce leather goods ethically and efficiently in Los Angeles and Mexico. Her company not only helps brands bring their visions to life, but also makes sustainability and transparency accessible to small and mid-sized businesses.



KATHERINE KIRCHHOFF

Her work sparked a deep interest in material science and sustainable design. Aguirre went on to study at USC, where she pioneered a new academic path pursuing a dual master's degree in architecture and building science.

Graduating in 2021, Aguirre entered another male-dominated industry – architecture – with the same resilience. She has since won numerous accolades, including the Paul Welch Scholarship, the Jim House Scholarship, the LAA Scholarship, Women in STEM honors, and the Great Minds in STEM award. At her firm, Ac Martin, Aguirre helped pioneer the internship program, actively participating in hiring and mentoring high school and college students seeking meaningful professional experience.

As head of product design at healthcare provider and AI company Akido Labs, she has designed and scaled platforms that have reduced the cost of patient visits by 90% and enabled doctors to see six times more patients, helping address the nation's physician shortage while improving care quality. Gee's AI-driven care model was featured in Fast Company and presented at MIT's AI Symposium for its potential to transform access to care globally. She has since scaled the program across a 500,000-patient network, leading implementation of new models of care that blend technology with human connection.

Gee serves on the Akido AI Ethics Council, a cross-institutional initiative with Caltech and USC, and advises the nonprofit Future Communities Institute, focused on tech-enabled care programs and civic innovation.


